The Hunter agrees to assume every risk arising out of his participation in the Hunt Expeditions and does hereby release, indemnify, and save harmless, Montana Big Game Pursuits, its owners, agents and employees from and against all claims, demands, actions, costs and expenses (including counsel fees) in respect of death, injury, loss or damage to person or property, whatsoever, wheresoever, and howsoever caused, arising out of or in connection with the taking part in any hunt or the undertaking of a Hunt Expedition notwithstanding that the same may have been contributed to or occasioned by any act of failure to act (including without limitation, negligence) on the part of Montana Big Game Pursuits, its owners, agents or employees.
